

Raya Petaling, Bangka, 33173, Bangka Belitung, Indonesia and AL-HIDAYAH WAQAF FOUNDATION FOR EDUCATION AND SOCIAL DEVELOPMENT, 390 M.7, Tambon Tachang, Bangkhlam, Songkhla 90110 Thailand agree to cooperate on academic programs based on the principles of equality, reciprocity, fairness, and willingness: as well as with honesty and faithfulness: and to abide by the laws and regulations of our respective nations.

- A. This Moll will be a framework for mutual understanding and for promoting scholar and student exchanges, and sharing of academic programs, where deemed appropriate. Such proposed activities my include the following:
1. Joint academic programs;
 2. Exchange of faculty members, students, and visiting professors;
 3. Exchange of Diploma, Undergraduate and Graduate students for short courses and shared learning programs;
 4. Joint collaboration in research and publications;
 5. And other international cooperative and exchange programs that may be suggested by either party.
- B. The development and implementation of each and every program as suggested in this Moll shall be mutually agreed upon, and signed by representatives of both parties.
- C. For issues not specifically stipulated in this MoU, a supplementary agreement (annex) may be written, which would then form a part of this MoU.
- D. Full autonomy of either party shall not be affected nor diminished by the execution of this MoU.
- E. This MoU shall be in effect for five (5) years from the date of signing and may be subject to revision or extension by mutual agreement. In addition, this MoU may be terminated by either party with written notice within six months prior to requested termination date.
- F. This Moll is written in English and Bahasa Indonesia and each party shall retain one copy with signatures of both parties.
- G. Should this Moll contravene any heretofore undiscovered or newly implemented rules and regulations of the governing body of either party, such notice shall be given and require a revision, annex, or termination of this MoU.




